_____ Personal Identification in the form of a picture ID of custodial adult enrolling student.

_____ Student's Birth Certificate or Passport (*must be original with raised seal*). A copy will be made for the file.

_____ Student's Social Security Card or proof of number (optional).

_____ Proof of residency such as a purchase/construction contract, home mortgage agreement, signed rental agreement, voter registration card, insurance policy on dwelling, current utility (gas, electric, water, phone) bill or a notarized Affidavit of Residency form which can be found on the first page of FinalForms. If in the process of building or purchasing a home, you must provide a sworn statement from the builder/realtor confirming you will reside in the home within 90 days of entry.

_____ Student's complete Immunization Records (the law allows for 14 days following entry for compliance).
